**RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING CHANGE ORDER NO. 1 TO COMPASS CONSTRUCTION, INC. FOR THE HARKER AVENUE AND 2 BISCAYNE BLVD. SLIP-LINING OF CORRUGATED METAL STORM WATER PIPING PROJECT**

**WHEREAS**, the Township of West Deptford (hereinafter referred to as "Township") awarded a contract for the Harker Avenue and 2 Biscayne Blvd. slip-lining of corrugated metal storm water piping project (hereinafter referred to as the "Project") to Compass Construction, Inc., pursuant to Resolution #2018-207 adopted on August 1, 2018, in the total contract amount of \$160,000; and

**WHEREAS**, it has been determined that a Change Order No. 1 to the original contract is required for additional material and labor costs associated with the Project; and


**WHEREAS**, Compass Construction, Inc. has submitted a proposal dated August 30, 2018 outlining the additional costs in the total amount of \$19,931.54; and

**WHEREAS**, T&M Associates has submitted a letter dated August 30, 2018 outlining the additional costs and recommending the approval of Change Order No. 1 in the total amount of \$19,931.54 for a revised total contract amount of \$179,931.54.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey on this 5<sup>th</sup> day of September, 2018 that the Township of West Deptford does hereby authorize Change Order No. 1 to the contract with Compass Construction, Inc. for the Harker Avenue and 2 Biscayne Blvd. slip-lining of corrugated metal storm water piping project in the total amount of \$19,931.54, for a revised total contract amount of \$179,931.54.
