**RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD APPOINTING AN ALTERNATE
FUND COMMISSIONER FOR THE TOWNSHIP OF WEST DEPTFORD**

WHEREAS, the Township of West Deptford is a member of the Gloucester, Salem, Cumberland Counties Municipal Joint Insurance Fund, hereinafter referred to as the FUND; and

WHEREAS, the Bylaws of the FUND require that in the manner generally prescribed by law, each Member shall be permitted to appoint an Alternate Fund Commissioner to the Fund; and

WHEREAS, the Alternate Fund Commissioner shall be either a member of the local unit's governing body or one of its employees and shall represent the Member in the absence of the Fund Commissioner; and

WHEREAS, N.J.A.C. 11:15-2.6 states that an Alternate Fund Commissioner who is a member of the appointing local unit's governing body, shall hold office for two years or for the remainder of his/her term of office as a member of the local unit's governing body, whichever shall be less; and

WHEREAS, N.J.A.C. 11:15-2.6 states that an Alternate Fund Commissioner who is an employee of the appointing Member shall hold office at the pleasure of the Member and can be removed by the Member at any time without cause; and

WHEREAS, Christine Greenwood was appointed as Alternate Fund Commissioner for the Township pursuant to Resolution #2018-18 adopted by the Township Committee on January 3, 2018; and

WHEREAS, Ms. Greenwood has announced her retirement effective September 30, 2018; and






