**RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING THE  
DISASSEMBLY AND DISPOSAL BY SCRAPPING OF THE FITNESS EQUIPMENT NO  
LONGER NEEDED AT THE RIVERWINDS COMMUNITY CENTER**

**WHEREAS**, the Township of West Deptford (hereinafter referred to as "Township") owns and operates the RiverWinds Community Center (hereinafter referred to as "Community Center") located in the Township; and

**WHEREAS**, there is a Fitness Center located in the Community Center which contains various pieces of fitness equipment; and

**WHEREAS**, it has been determined that twelve (12) pieces of the existing fitness equipment are approximately fifteen (15) years old and in need of replacement; and

**WHEREAS**, the Township has purchased new pieces of fitness equipment to replace the older and outdated pieces of equipment; and

**WHEREAS**, the older pieces have been inspected and an estimate (see attached Quotation from Absolute Fitness Solutions) was prepared regarding the value of the twelve (12) older pieces of fitness equipment; and

**WHEREAS**, based upon the total value of the twelve (12) pieces of fitness equipment, the Township has determined that it is in its best interest to use Township resources to disassemble the twelve (12) pieces of fitness equipment and dispose of them by scrapping same.

**NOW, THEREFORE BE IT RESOLVED** by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey, that the Township does hereby authorize the disassembly of the twelve (12) outdated pieces of fitness equipment, per the attached Quotation, located in the RiverWinds Community Center Fitness Center, as determined by the Fitness Center Management, and to dispose of the twelve (12) pieces of fitness equipment by scrapping same by using Township resources.
