**RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING THE DISPOSAL
BY SCRAPPING OF PUBLIC WORKS EQUIPMENT NO LONGER NEEDED BY THE
TOWNSHIP OF WEST DEPTFORD**

WHEREAS, the Township of West Deptford (hereinafter referred to as "Township") owns several pieces of equipment that are used by the Township's Public Works Department; and

WHEREAS, it has been determined that several pieces of the existing equipment, as listed below, are old and/or broken and in need of replacement:

AT the Jessup Road Water Tower

1. (1) – Bobcat Walk behind mower – engine Blown - \$15
2. (1) – Old Simplicity Brand Snow Blower - \$15
3. (1) – Old Concrete Mixer - \$20
4. (3) – Hustler rider mowers - \$30/each
5. (2) – Bobcat riding mowers – \$30/each
6. (1) – John Deere riding mower - \$40
7. (2) – John Deere 1200 3 wheel Turf Equipment - \$25/each
8. (8) – Redmax Weedwackers - \$10/each

AT the Public Works Garage

1. (1) – Honda Snowblower - \$25
2. (1) – Yard Machine Snowblower - \$25
3. (1) – White Outdoor Snowblower - \$25
4. (1) – Billy Goat Brush Cutter (blown transmission) - \$25
5. (2) – Honda pressure washer - \$15/each
6. (1) – Honda Trash Pump - \$10

WHEREAS, the older pieces have been inspected by the Director of Public Works who has determined the value of the equipment to be less than \$500; and



hereby authorize the disposal of the old/broken and outdated pieces of Public Works equipment, as determined by the Director of Public Works and listed above, by scrapping same by using Township resources.
