**RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING

(CHARLES JONES LLC V. WEST DEPTFORD TOWNSHIP)**

WHEREAS, a lawsuit was filed in the Gloucester County Superior Court/Law Division entitled Charles Jones LLC, Plaintiff v. West Deptford Township and Lee Ann DeHart, Defendants under Docket No: GLO-L-1004-18; and

WHEREAS, the Parties desire to amicably settle this matter without the need for further Court involvement; and

WHEREAS, a settlement has been reached wherein the Township of West Deptford (hereinafter referred to as "Township") has agreed to release the records previously requested in Plaintiff's OPRA request with redactions of personal information and will pay attorney's fees to Plaintiff's Counsel in the amount shown on the invoice provided by Plaintiff's Counsel and dated September 21, 2018; and

WHEREAS, Charles Jones LLC will, through their attorney, voluntarily dismiss and/or withdraw the Complaint filed in the lawsuit entitled Charles Jones LLC, Plaintiff v. West Deptford Township and Lee Ann DeHart, Defendants under Docket No: GLO-L-1004-18.


NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of West Deptford, County of Gloucester, and State of New Jersey as follows:

1. That the Township Committee does hereby authorize and approve the settlement of litigation entitled Charles Jones LLC, Plaintiff v. West Deptford Township and Lee Ann DeHart, Defendants under Docket No: GLO-L-1004-18 as outlined above.

2. That the Mayor and/or Acting Township Administrator be and is hereby authorized to execute any and all documents related to this settlement.
