RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING AND APPROVING THE ENDORSEMENT OF THE SEWER CONNECTION APPLICATION SUBMITTED BY WESTWOOD GOLF CLUB

WHEREAS, Westwood Golf Club has submitted a sewer connection application to the Township of West Deptford (hereinafter referred to as "Township") to extend the sewer system on its property to serve the Westwood Golf Club Clubhouse located at 850 Kings Highway in the Township; and

WHEREAS, as part of the application process, the sewer connection application is required to be endorsed by the Township and submitted to the Gloucester County Utilities Authority ("GCUA"); and

WHEREAS, the Township's Engineer has reviewed the sewer connection application and supporting documentation as submitted by Westwood Golf Club and has determined that adequate excess capacity exists within the Township's wastewater collection facilities to adequately accommodate the extension of the sewer system; and

WHEREAS, the Township's Engineer has submitted the attached letter dated October 19, 2018 recommending endorsement of the sewer connection application by the Township.

NOW, THEREFORE BE IT RESOLVED by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey on this 7th day of November, 2018 that the Township of West Deptford does hereby authorize and approve the endorsement of the sewer connection application submitted by Westwood Golf Club to extend the sewer system on its property to serve the Westwood Golf Club Clubhouse located at 850 Kings Highway in the Township of West Deptford pursuant to the recommendation in the October 19, 2018 letter from the Township Engineer.

BE IT FURTHER RESOLVED that Keith Lamb, Acting Water and Sewer Superintendent for the Township of West Deptford, be and is hereby authorized to endorse the

sewer connection application on behalf of the Township.


