**RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD IN SUPPORT OF NJ TRANSIT'S
RECOMMENDATIONS FOR THE ESTABLISHMENT OF BUS STOPS WITHIN THE
TOWNSHIP OF WEST DEPTFORD**

WHEREAS, NJ Transit has made changes to its 402 and 455 bus route which runs through the Township; and

WHEREAS, the changes to the 402 and 455 bus route would create more bus stops to accommodate the new Amazon facility located in the Township; and

WHEREAS, pursuant to N.J.S.A. 39:4-8(e), the Township Committee supports the recommendations made by NJ Transit for the establishment of bus stops in the Township.

NOW, THEREFORE BE IT RESOLVED by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey that the Township Committee does hereby support the establishment of the following bus stops within the Township of West Deptford:

BUS STOPS

1. Along Mantua Grove Road, northbound, on the easterly side thereof at:
 - a. Patsy Court - far side
Beginning at the northerly curb line of Patsy Court and extending 100 feet northerly therefrom.
 - b. Forest Parkway (South) - near side
Beginning at the southerly curb line of Forest Parkway and extending 105 feet southerly therefrom.
 - c. Forest Parkway (North) - near side
beginning at the southerly curb line of Forest Parkway and extending 105 feet southerly therefrom.
2. Along Mantua Grove Road, southbound, on the westerly side thereof at:
 - a. Forest Parkway (North) - far side
Beginning at the southerly curb line of Forest Parkway and extending 100 feet southerly therefrom.


- b. Forest Parkway (South) - near side
Beginning at the northerly curb line of Forest Parkway and extending 105 feet northerly therefrom.
 - c. Patsy Court - mid block
Beginning 555 north of the northerly curb line of Patsy Court and extending 135 feet northerly therefrom.
3. Along Grove Road, southbound, on the westerly side thereof at:
- a. Denston Road - far side
Beginning at the southerly curb line of Denston Road and extending 100 feet southerly therefrom.
 - b. Mantua Grove Road - near side
Beginning at the northerly curb line of Mantua Grove Road and extending 105 feet northerly therefrom.
4. Along Grove Road, northbound, on the easterly side thereof at:
- a. Mantua Grove Road - far side
Beginning at the northerly curb line of Mantua Grove Road and extending 100 feet northerly therefrom.
 - b. Denston Road - near side
Beginning at the southerly curb line of Denston Road and extending 105 feet southerly therefrom.
5. Along Mid Atlantic Parkway, northbound, on the easterly side thereof at:
- a. Grove Road - far side
Beginning at the northerly curb line of Grove Road and extending 100 feet northerly therefrom.
 - b. Metropolitan Avenue - near side
Beginning at the southerly curb line of Metropolitan Avenue and extending 105 feet southerly therefrom.
 - c. Imperial Way - near side
Beginning at the southerly curb line of Imperial Way and extending 105 feet southerly therefrom.
6. Along Mid Atlantic Parkway, southbound, on the westerly side thereof at:
- a. Imperial Way - near side
Beginning at the northerly curb line of Imperial Way and extending 105 feet northerly therefrom.
 - b. Metropolitan Avenue - near side
Beginning at the northerly curb line of Metropolitan Avenue and extending 105 feet northerly therefrom.

- c. Grove Road - near side
Beginning at the northerly curb line of Grove Road and extending 105 feet
northerly therefrom.

BE IT FURTHER RESOLVED that Township of West Deptford will enforce the needed
traffic regulations governing the aforementioned bus stop locations and provide the necessary
police security to ensure the safety of the traveling public.


