RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING EXECUTION OF AGREEMENT FOR THE USE OF COMMUNITY BLOCK GRANT FUNDS BETWEEN GLOUCESTER COUNTY, NEW JERSEY AND THE TOWNSHIP OF WEST DEPTFORD IN THE AMOUNT OF \$50,000 (DRAINAGE AND ROAD IMPROVEMENTS AT FIRST AVENUE FROM STATE ROUTE 45 TO MANHATTAN AVENUE)

WHEREAS, the County of Gloucester (hereinafter referred to as "County") has received a PY 2018 Community Development Block Grant (hereinafter referred to as "CDBG") under Title 1 of the Housing and Community Development Act of 1974, as amended, to carry out various housing and community development activities in its unincorporated areas and in municipalities participating in the County CDBG Program; and

WHEREAS, the Township of West Deptford (hereinafter referred to as "Township") is a participant in the County CDBG Program; and

WHEREAS, the Township has a need to make drainage and road improvements at First Avenue from State Route 45 to Manhattan Avenue; and

WHEREAS, these types of improvements have been determined to be CDBG eligible by the County.

NOW, THEREFORE BE IT RESOLVED by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey on this 6th day of March, 2019 that the Township of West Deptford does hereby authorize and approve the execution of the attached Agreement for Use of Community Development Block Grant Funds between Gloucester County, New Jersey and the Township of West Deptford, in the amount of \$50,000, for drainage and road improvements at First Avenue from State Route 45 to Manhattan Avenue.


