RESOLUTION #2019- 106

RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AMENDING RESOLUTION #2018-307 – IN SUPPORT OF NJ TRANSIT’S RECOMMENDATIONS FOR THE ESTABLISHMENT OF BUS STOPS WITHIN THE TOWNSHIP OF WEST DEPTFORD

WHEREAS, the Township of West Deptford (hereinafter referred to as “Township”) adopted Resolution #2018-307 on November 26, 2018 in support of NJ Transit’s recommendation for the establishment of bus stops within the Township of West Deptford; and

WHEREAS, pursuant to Resolution #2018-307, bus stops would be created to accommodate the new Amazon facility located in the Township; and

WHEREAS, the State has recommended changes to some of the newly created bus stop locations; and

WHEREAS, the recommended amendments to the previously approved bus stops are as follows:

1. Mantua Grove Road, northbound, on the easterly side thereof at:
 - a. Patsy Court – mid block – Beginning 555 feet north of the northerly curblines of Patsy Court and extending 135 feet northerly therefrom.
 - b. Forest Parkway (South) – far side – Beginning at the northerly curblines of Forest Parkway and extending 100 feet northerly therefrom; and

WHEREAS, the Township Committee approves of said amendments.

NOW, THEREFORE BE IT RESOLVED by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey, on this 6th day of March, 2019 that the Township of West Deptford does hereby amend Resolution #2018-307 to reflect approval of the following bus stop locations:

1. Mantua Grove Road, northbound, on the easterly side thereof at:

- a. Patsy Court – mid block – Beginning 555 feet north of the northerly curbline of Patsy Court and extending 135 feet northerly therefrom.
- b. Forest Parkway (South) – far side – Beginning at the northerly curbline Forest Parkway and extending 100 feet northerly therefrom; and

BE IT FURTHER RESOLVED that all other bus stop locations contained in Resolution #2018-307 shall remain in full force and effect.

ADOPTED at the meeting of the Township Committee of the Township of West Deptford held on March 6, 2019.
