RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AMENDING RESOLUTION #2019-87– AWARDING A CONTRACT FOR THE RIVERWINDS SITE CONCRETE AND BUILDING IMPROVEMENTS TO REFLECT ENTIRE LIST OF BIDDERS FOR THIS PROJECT

WHEREAS, the Township of West Deptford (hereinafter referred to as “Township”) adopted Resolution #2019-87 on February 6, 2019 awarding a contract for the RiverWinds Site Concrete and Building Improvements (Joseph Porretta Builders, Inc.); and

WHEREAS, the Township Engineer’s letter to the Township dated February 1, 2019 recommended the awarding of a contract to Joseph Porretts Builders, Inc. as they were the lowest responsible bidder along with a list of all bidders who responded to the bid; and

WHEREAS, the Township Engineer recognized an error had occurred in his February 1, 2019 letter by not including one of the bidders who responded to the bid; and

WHEREAS, the bidder who was not included in the February 1, 2019 letter was W.J. Gross, Inc.; and

WHEREAS, the Township Engineer has submitted a revised bid recommendation letter dated February 12, 2019 that now includes all contractors who bid on the project.

NOW, THEREFORE BE IT RESOLVED by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey, on this 6th day of March, 2019 that the Township of West Deptford does hereby amend Resolution 2019-87 to reflect the entire list of bidders as follows:
