RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING THE SALE OF SURPLUS VEHICLES NO LONGER NEEDED FOR PUBLIC USE ON AN ONLINE AUCTION WEBSITE

WHEREAS, the Township of West Deptford has determined that the property described on Schedule A attached hereto and incorporated herein is no longer needed for public use; and

WHEREAS, the Local Unit Technology Pilot Program and Study Act (P.L. 2001, c.30) authorizes the sale of surplus personal property no longer needed for public use through the use of an online auction service; and

WHEREAS, the Township of West Deptford intends to utilize the online auction services of GovDeals located at www.govdeals.com; and

WHEREAS, the sales are being conducted pursuant to the Division of Local Government Services' Local Finance Notice 2008-9.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of West Deptford, County of Gloucester, and State of New Jersey as follows:

1. That the Township of West Deptford is hereby authorized to sell the surplus personal property as indicated on Schedule A on an online auction website entitled www.govdeals.com.
2. The surplus property as identified shall be sold in an "as-is" condition without express or implied warranties with the successful bidder required to execute a Hold Harmless and Identification Agreement concerning the use of said surplus property.
3. The Township reserves the right to accept or reject any bid submitted.
4. The successful bidder must remove the item(s) within twenty (20) business days from the time and date of purchase. Purchases will be released only upon payment as specified.

5. Successful bidders are responsible for the loading and removal of any and all property awarded to them from the place where the property is located as indicated on the website.
6. Successful bidder shall make, at their expense, all arrangements and perform all work necessary, including packaging, loading and transportation of the property. Under no circumstances shall the Borough be responsible for packaging, loading or shipping.
