**RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING THE RENEWAL OF THE CONTRACT FOR TEMPORARY LABOR SERVICES BETWEEN THE TOWNSHIP OF WEST DEPTFORD AND SHARPLINK STAFFING, LLC**

**WHEREAS**, the Township of West Deptford (hereinafter referred to as "Township") awarded a contract to Sharplink Staffing, LLC for temporary labor services pursuant to Resolution 2018-160 adopted on June 6, 2018; and

**WHEREAS**, the contract, as referenced above, contains an option to renew the contract for an additional twelve (12) month period at the mutual consent of both parties at the hourly rate as listed in the bid proposal; and

**WHEREAS**, the Township has chosen to renew the contract with Sharplink Staffing, LLC pursuant to the option for year 2; and

**WHEREAS**, a Certification has been issued by the Chief Financial Officer of the Township of West Deptford certifying that sufficient funds have been appropriated and are available to cover this Contract, the original of said Certification is attached to the original of this Resolution and shall be filed in the office of the Township Clerk.

**NOW, THEREFORE BE IT RESOLVED** by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey that the Township of West Deptford does hereby authorize and approve the renewal option for year 2 as part of the contract for temporary labor services to Sharplink Staffing, LLC.
