A RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING AN APPLICATION TO THE COUNTY OF GLOUCESTER, DEPARTMENT OF ECONOMIC DEVELOPMENT FOR COMMUNITY DEVELOPMENT BLOCK GRANT FUNDING

WHEREAS, the Township of West Deptford is eligible for an annual submission to the County of Gloucester for Community Development Block Grant Funding; and

WHEREAS, the Township of West Deptford has found needs within the municipality which are eligible for submission for said funding; and

WHEREAS, the Township of West Deptford desires to make improvements to the Township's streets and infrastructure associated with the same.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Township Committee of the Township of West Deptford, that the Township Committee does hereby make an application to the County of Gloucester, Department of Economic Development for Community Development Block Grant Funds in the amount of \$ 50,000.00 for improvements to resurface Storrie Avenue from Brewer Avenue to Hessian Avenue and Snyder Avenue from Spiegle Avenue to Franklin Avenue. Storrie Avenue and Snyder Avenue are located in Census Tract 500201, Block Group 2; and

BE IT FURTHER RESOLVED that any expenditures over and beyond the initial \$50,000.00 Community Development Block Grant shall be borne solely by the Township of West Deptford, and shall not be reimbursed through further grant funds; and

BE IT FURTHER RESOLVED that Lee Ann DeHart, Acting Township Administrator, be and is hereby authorized to execute said application for funding on behalf of the Township of West Deptford.
