RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING EXECUTION OF SHARED SERVICES AGREEMENT BY AND BETWEEN THE GLOUCESTER COUNTY IMPROVEMENT AUTHORITY AND THE TOWNSHIP OF WEST DEPTFORD FOR THE USE OF HEAVY EQUIPMENT

WHEREAS, the Township of West Deptford and The Gloucester County Improvement Authority wish to enter into a Shared Services Agreement (“Agreement”) for use of heavy equipment; and

WHEREAS, pursuant to the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et seq., municipalities and other local units may enter into Shared Services Agreements with other governmental units by adoption of a Resolution therefore; and

WHEREAS, The Gloucester County Improvement Authority (“Authority”) and the Township of West Deptford (“Township”), hereinafter collectively (the “Parties”) are local units as defined by N.J.S.A. 40A:65-3; and

WHEREAS, the Township and the Authority have concluded that the Authority and West Deptford Residents will benefit from the sharing of certain defined services; and

WHEREAS, the Parties each maintain certain Heavy Equipment such as rollers, bull dozers, front end loaders, jet vacs, street sweepers, etc., which from time to time may be needed by the other party; and

WHEREAS, to promote efficiencies to both Parties, the Parties recognize that the sharing of such equipment will be more efficient in many instances on a short-term basis than the rental or purchase of such equipment; and

WHEREAS, the Agreement shall be effective for a period of five (5) years commencing upon the execution date of the Agreement.


