**RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING AWARD OF CONTRACT FOR POLICE CONSULTANT SERVICES TO THE RODGERS GROUP, LLC OF ISLAND HEIGHTS, NEW JERSEY FOR THE TOWNSHIP OF WEST DEPTFORD**

**WHEREAS**, the Township of West Deptford is a duly constituted municipal corporation having its offices at 400 Crown Point Road, West Deptford, New Jersey; and

**WHEREAS**, N.J.S.A. 40A:11-5(1)(a)(i) empowers the governing body and its autonomous agencies to award contracts for extraordinary unspecifiable service without competitive bidding; and

**WHEREAS**, the Township of West Deptford has a need for these services and other contracts which, by their nature, are not required or suitable to be awarded through a public bidding process pursuant to N.J.S.A. 40A:11-5 et seq.; and

**WHEREAS**, the Township of West Deptford has determined the need for extraordinary unspecifiable service to assist the West Deptford Police Department in the development of a customized policy manual and securing NJSACOP Accreditation for the West Deptford Police Department which by its nature is not suitable to be awarded through a public bidding process pursuant to N.J.S.A.40A:11-5 et seq.; and

**WHEREAS**, the Township Committee of the Township of West Deptford has reviewed the Proposal submitted and has determined that The Rodgers Group, LLC has submitted an acceptable consulting service proposal for this work.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of West Deptford, that The Rodgers Group, LLC of Island Heights, New Jersey be and hereby is awarded the contract for Police Consultant Services to assist the West Deptford Police Department in the development of a customized policy manual and securing NJSACOP accreditation for the Township of West Deptford Police Department in the total amount not to exceed \$39,000.00 and in accordance with and as more particularly described in the proposal submitted by The Rodgers Group, LLC.

**BE IT FURTHER RESOLVED** that the Mayor and/or Acting Township Administrator be and hereby are authorized to execute a contract for said services on behalf of the Township of West Deptford.
