**RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD ACKNOWLEDGING AND APPROVING THE RENEWAL OF THE SHARED SERVICES AGREEMENT BETWEEN THE TOWNSHIP OF WEST DEPTFORD AND THE WEST DEPTFORD BOARD OF EDUCATION FOR SPECIAL LAW ENFORCEMENT OFFICER (SLEO) CLASS III SERVICES IN THE WEST DEPTFORD SCHOOL DISTRICT**

**WHEREAS**, the Township of West Deptford (hereinafter referred to as "Township") through the West Deptford Police Department, has provided a Special Law Enforcement Officer Class III (SLEO III) Officer to the West Deptford School District; and

**WHEREAS**, the Township and the West Deptford Board of Education (hereinafter referred to as "School Board") recognize the benefit of a SLEO III program to the citizens of the Township and the students, staff and parents of the West Deptford School District in providing police protection to the students and staff reducing juvenile delinquency through a collaborative approach between Law Enforcement and the School Board that focuses on education, prevention, communication and information sharing; and

**WHEREAS**, the Township, through the West Deptford Police Department has agreed to assign Special Law Enforcement Officers Class III in the elementary, middle and high schools located in the Township; and

**WHEREAS**, N.J.S.A. 40A:65-1 et seq. ("Shared Services Law") specifically authorizes local government units, including counties and municipalities, to enter into shared services agreements; and


**WHEREAS**, the attached Shared Services Agreement (hereinafter referred to as "Agreement") has been approved by the parties and outlines the responsibilities of each Party to the Agreement to achieve the goals as outlined above and was executed by the Township and West Deptford School District on September 1, 2018; and

**WHEREAS**, this Shared Services Agreement will automatically renew under the same terms from September 1, 2019 until June 30, 2020 and each September thereafter unless terminated by either party.

**NOW, THEREFORE BE IT RESOLVED** by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey on this 17th day of July, 2019 that the Township of West Deptford does hereby acknowledge and approve the renewal of the attached Shared Services Agreement Between the Township of West Deptford and the West Deptford Board of Education for Special Law Enforcement Officer Class III Services in the West Deptford School District, pursuant to the terms of the attached Agreement.
