Brothers Dry Cleaning, LLC d/b/a Orange Cleaners, for and in consideration of the waiver by West Deptford Township of any accrued interest charges on the above outstanding meter bill account balance, does hereby agree to pay to the Township of West Deptford the total sum of \$11,448.31 (i.e., without interest) in twenty-four (24) monthly installments as follows:

Payments 1 through 23	\$477.00
Payment 24	\$477.31

Each installment must be received by West Deptford Township on or before the first day of each month, with the first payment to be made on or before September 1, 2019.

All payments shall be paid online at westdeptford.com or sent to West Deptford Township, Municipal Building, 400 Crown Point Road, West Deptford, New Jersey 08086.

Brothers Dry Cleaning, LLC d/b/a Orange Cleaners further agrees to remain current on all new water billings on this account. In the event any monthly payment under the Agreement is received late and/or unpaid or Brothers Dry Cleaning, LLC d/b/a Orange Cleaners fails to remain current on all new water billings on this account, then the entire outstanding water bill balance owed at that time (i.e., under this Payment Agreement) shall be immediately due and payable and shall then begin to accrue interest at the current rate established by West Deptford Township for delinquent water accounts.

This Payment Agreement constitutes the final, complete, entire and exclusive agreement between the parties with respect to the subject matter hereof and it supersedes any previous or contemporaneous agreements, whether written or oral.

No change, addition to or modification of any portion of this Payment Agreement shall be valid or binding upon either party unless in writing and signed.
