RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING THE DONATION OF FITNESS EQUIPMENT NO LONGER NEEDED AT THE RIVERWINDS COMMUNITY CENTER TO THE CITY OF WOODBURY

WHEREAS, the Township of West Deptford (hereinafter referred to as "Township") owns and operates the RiverWinds Community Center (hereinafter referred to as "Community Center") located in the Township; and

WHEREAS, there is a Fitness Center located in the Community Center which contains various pieces of fitness equipment; and

WHEREAS, three (3) pieces of existing fitness equipment are being replaced as outdated and unusable and are hence, no longer needed at the Community Center; and

WHEREAS, the pieces of equipment have been inspected and an estimate (see attached Quotation from Absolute Fitness Solutions) was prepared regarding the nominal and/or no value of the three (3) older pieces of fitness equipment; and

WHEREAS, the City of Woodbury has expressed an interest in taking ownership of the equipment and removing the three (3) pieces of fitness equipment for their own use; and

WHEREAS, based upon the total nominal and/or no value of the three (3) pieces of fitness equipment and the cost the Township would incur to remove or store them, the Township has determined that it is in its best interest to allow the City of Woodbury to remove and take ownership of the three (3) pieces of fitness equipment for their own use; and

WHEREAS, the Township of West Deptford has prepared a "Fitness Equipment Donation Agreement" that requires execution by the Township and the City of Woodbury to finalize the donation.

NOW, THEREFORE BE IT RESOLVED by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey, that the Township does hereby approve and authorize the donation to the City of Woodbury of the three (3) pieces of fitness

equipment upon execution of the "Fitness Equipment Donation Agreement" located in the RiverWinds Community Center Fitness Center and to transfer ownership of the three (3) pieces of fitness equipment to the City of Woodbury, who will be responsible for their removal; and

BE IT ALSO RESOLVED by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey that Lee Ann DeHart shall be and is hereby authorized to execute the "Fitness Equipment Donation Agreement" on behalf of the Township of West Deptford.


