RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING A PRIVATE SALE OF VACANT LAND KNOWN AS BLOCK 253, LOTS 17, 18, 19 & 20 TO CONTIGUOUS PROPERTY OWNERS PURSUANT TO N.J.S.A. 40A:12-13(B)(5) BY SEALED BID

WHEREAS, the Township of West Deptford has determined that it has no public purpose for parcels of land known as Block 253, Lots 17, 18, 19 & 20 located in the Township of West Deptford and said lot being less than the minimum size required for development under the Municipal Zoning Ordinance; and

WHEREAS, pursuant to N.J.S.A. 40A:12-13(b)(5), the municipality may sell to the contiguous property owners by private sale any such lot(s) to the highest bidder; and

WHEREAS, the Township Committee has determined to offer for sale the lots to the contiguous property owners; and

WHEREAS, the tax records for said properties reflect the following value:

Block 253, Lots 17, 18, 19 & 20, Land \$42,100.00

WHEREAS, the Township Committee has set the minimum bid price for the lots at a total of \$42,100.00; and

WHEREAS, the Township Committee will accept sealed bids from each contiguous property owner to purchase said lots.

NOW, THEREFORE BE IT RESOLVED by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey as follows:

- That the Township Committee has determined that Block 253, Lots 17, 18, 19 & 20
 are not needed for any public purpose and that the lots constitutes vacant parcels of
 land.
- 2. That the Township Committee hereby sets as the minimum sale price for the lot at a total of \$42,100.00.

- 3. That the lots are being sold by a private sale to the contiguous property owners by sealed bid.
- 4. That any sealed bid must be submitted to the attention of the Township Clerk on or before 10:00 a.m. on September 13, 2019 as follows:
 - a. A sealed envelope with written bid amount enclosed shall be addressed and delivered to the Township as follow (Township of West Deptford, 300 Crown Point Road, West Deptford, New Jersey 08086, Att: Lee Ann DeHart, Registered Municipal Clerk, Reference: Sealed Bid/Land Purchase for Block 253, Lots 17, 18, 19 & 20.
 - b. Any bidder must submit a written dollar amount which must be paid in either cash or by certified cash or bank check within thirty (30) days of the award of the sealed bid. The Borough will not accept any financing for the purchase of the lots.
 - c. The offer shall be made to the Township Clerk to purchase the lots.
 - d. Settlement shall be completed within thirty (30) days of the award of the sealed bid.
 - e. The Township shall convey ownership of the lots by a Quitclaim Deed and by reference to the Block and Lot numbers and without any legal description.
 - f. The successful bidder will be given the opportunity to purchase title insurance on the property at their sole cost. In the event the Township cannot convey free and clear title, then this sale shall be declared null and void and the purchase price shall be returned to the successful bidder.
- 5. The lots are being sold under and subject to the following terms and conditions:
 - a. The properties are being sold in their "as is" condition.
 - The properties are being sold subject to any and all existing easements,
 covenants and restrictions of record.

- The properties are being sold subject to all existing Township of West
 Deptford Zoning and Land Use laws.
- 6. The Township reserves the right to reject any and all bids for any reason.
