RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING EXECUTION OF AN ADMINISTRATIVE CONSENT ORDER (“ACO”) BETWEEN THE NEW JERSEY DEPARTMENT OF ENVIRONMENTAL PROTECTION, THE TOWNSHIP OF WEST DEPTFORD, AND FHG REALTY URBAN RENEWAL, LLC (ACO EA ID#: NEA170001-0820-01-1002.1)

WHEREAS, the Township of West Deptford (hereinafter referred to as “Township”) owned and/or currently owns the property known as Block 328 Lots 7 and 7.01 in the Township of West Deptford, New Jersey; and

WHEREAS, as the result of compliance evaluations conducted at that facility on July 6, 2018, September 14, 2018, October 4, 2018, November 20, 2018 the New Jersey Department of Environmental Protection (hereinafter referred to as “NJDEP”), NJDEP determined that FHG Realty Urban Renewal, LLC and the Township had failed to comply with applicable State requirements; and

WHEREAS, in order to resolve this matter without trial or adjudication, FHG Realty Urban Renewal, LLC, the Township and the NJDEP have agreed to the entry of an Administrative Consent Order; and

WHEREAS, the attached Administrative Consent Order has been prepared by the NJDEP and approved by the Township Committee.


NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of West Deptford, County of Gloucester, and State of New Jersey as follows:

1. That the Township Committee does hereby authorize and approve the execution of the attached Administrative Consent Order with NJDEP and FHG Realty Urban Renewal, LLC to address the failure to comply with applicable State requirements regarding the property known as Block 328 Lots 7 and 7.01 in the Township of West Deptford, New Jersey and to resolve this matter without trial or adjudication.

2. That the Mayor and/or Acting Township Administrator be and is hereby authorized to execute said Administrative Consent Order (ACO EA ID#: NEA170001-0820-01-1002.1) on behalf of the Township of West Deptford.
