**WHEREAS**, the Township of West Deptford (hereinafter referred to as "Township") has a need to award a contract for the supplying of inflatable and mechanical rides for West Deptford Family Fun Day to be held at the RiverWinds Community Center on September 21, 2019 (Rain Date September 22, 2019); and

**WHEREAS**, the Township has solicited for quotes for the supplying of inflatable and mechanical rides for West Deptford Family Fun Day; and

**WHEREAS**, the Township received one proposal dated August 16, 2019 from Circus Time Amusements and Entertainment (hereinafter referred to as "Circus Time"), which is attached hereto and incorporated herein; and

**WHEREAS**, Circus Time submitted the lowest responsible and responsive quote for the supplying of inflatable and mechanical rides for West Deptford Family Fun Day in an amount of \$10,265.00 as provided in the quote submitted to the Township; and

**WHEREAS**, a Certification has been issued by the Chief Financial Officer of the Township of West Deptford certifying that sufficient funds have been appropriated and are available to cover this contract and the original of said Certification is attached to the original of this Resolution and shall be kept on file at the Township office.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey on this 4th day of September, 2019, that a contract be and is hereby awarded to Circus Time Amusements and Entertainment of Pennsauken, New Jersey in the amount of \$10,265.00 as provided in the quote submitted to the Township, for the supplying of inflatable and mechanical rides for West Deptford Family Fun
