RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING THE SALE OF SURPLUS PERSONAL PROPERTY NO LONGER NEEDED FOR PUBLIC USE ON AN ONLINE AUCTION WEBSITE

- 4. The successful bidder must remove the item(s) within twenty (20) business days from the time and date of purchase. Purchases will be released only upon payment as specified.
- 5. Successful bidders are responsible for the loading and removal of any and all property awarded to them from the place where the property is located as indicated on the website.
- 6. Successful bidder shall make, at their expense, all arrangements and perform all work necessary, including packaging, loading and transportation of the property. Under no circumstances shall the Township of West Deptford be responsible for packaging, loading or shipping.
