WHEREAS, the Township of West Deptford (hereinafter "Township") has a need of a 2019 Chevrolet Tahoe; and

WHEREAS, the Chevrolet Tahoe can be purchased through State Contract #A88729 (T2776); and

WHEREAS, a Certification has been issued by the Chief Financial Officer of the Township of West Deptford certifying that sufficient funds have been appropriated and are available to cover this contract and the original of said Certification is attached to the original of this Resolution and shall be kept on file at the Township office; and

WHEREAS, public bids are not required when the purchase is under a state contract in accordance with N.J.S.A. 40A:11-12 of the Local Public Contracts Law.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of West Deptford, County of Gloucester, and State of New Jersey as follows:

1. That the Mayor or Acting Township Administrator be and hereby is authorized and directed to approve and forward a Purchase Requisition to Hertrich Fleet Services, Inc. for the purchase of a 2019 Chevrolet Tahoe in the amount of \$34,170.96 under State Contract #A88729 (T2776).
2. That the Mayor or Acting Township Administrator be and is hereby authorized to execute a contract on behalf of the Township.
3. That this Resolution or notice of purchase be published in the South Jersey Times.
