RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING THE PURCHASE OF A HEIL HIGH COMPACTION REAR LOADER DURAPACK 5000 25 CUBIC YARD EJECT. 2020 FREIGHTLINER M2-106 UNDER SOURCEWELL (NJPA) STATE CONTRACT #091219-THC

WHEREAS, the Township of West Deptford (hereinafter "Township") has a need of a HEIL High Compaction Rear Loader Durapack 5000 25 Cubic Yard Eject. 2020 Freightliner M2-106; and

WHEREAS, the HEIL High Compaction Rear Loader Durapack 5000 25 Cubic Yard Eject. 2020 Freightliner M2-106 can be purchased through Sourcewell State Contract #091219-THC; and

WHEREAS, a Certification has been issued by the Chief Financial Officer of the Township of West Deptford certifying that sufficient funds have been appropriated and are available to cover this contract and the original of said Certification is attached to the original of this Resolution and shall be kept on file at the Township office; and

WHEREAS, public bids are not required when the purchase is under a state contract in accordance with N.J.S.A. 40A:11-12 of the Local Public Contracts Law.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of West Deptford, County of Gloucester, and State of New Jersey as follows:

1. That the Mayor or Acting Township Administrator be and hereby is authorized and directed to approve and forward a Purchase Requisition to Mid-Atlantic Waste Systems for the purchase of a HEIL High Compaction Rear Loader Durapack 5000 25 Cubic Yard Eject. 2020 Freightliner M2-106 in the amount of \$198,210.30 under State Contract #091219-THC.

2. That the Mayor or Acting Township Administrator be and is hereby authorized to execute a contract on behalf of the Township.
3. That this Resolution or notice of purchase be published in the South Jersey Times.
