RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING CHANGE ORDER NO. 1 HESSIAN AVENUE STORMWATER SYSTEM REPAIR

WHEREAS, the Township of West Deptford (hereinafter referred to as "Township") awarded a contract for Hessian Avenue Stormwater System Repair in the Township of West Deptford (hereinafter referred to as the "Project") to Capela Construction Inc. pursuant to Resolution #2019-311 adopted on October 16, 2019, in the total contract amount of \$121,925.00; and

WHEREAS, it has been determined that a Change Order No. 1 to the original contract is required to account for a change in cost to the contractor because the 30" SDR17 HDPE pipe shown on the plans was too large to fit the existing CMP pipe due to the inside diameter of the existing pipe being smaller than anticipated and the additional cost of a 24" HDPE pipe that will fit the existing CMP pipe and grouting of annular void for slip-lining of 48" CMP with 30" HD for a total additional cost to the Township of \$12,245.20; and

WHEREAS, a \$7,200.00 reduction in cost to the Township for Traffic Control as itemized in Change Order No. 1; and

WHEREAS, T&M Associates has submitted Change Order No. 1 dated January 3, 2020 outlining the need for the amended contract cost to the Township; and

WHEREAS, T&M Associates, Township Engineer, has submitted a transmittal letter dated January 9, 2020 recommending the approval of Change Order No. 1 for an increased cost to the Township of \$5,045.20, for a new revised total contract amount of \$126,970.20.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey on this 5th day of February, 2020 that the Township Committee does hereby approve and authorize Change Order No. 1 to the contract with Capela Construction Inc. for Hessian Avenue Stormwater System Repair in the Township of West Deptford for an amended total contract amount of \$126,970.20.
