**RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING THE PURCHASE OF RAUSCH ECO STAR 400 CCTV BY THE TOWNSHIP OF WEST DEPTFORD AS PART OF THE HOUSTON-GALVESTON AREA COUNCIL COOPERATIVE PURCHASING PROGRAM**

**WHEREAS**, N.J.S.A. 52:34-6.2(b)(3) authorizes contracting units to purchase goods, or to contract for services, through the use of a nationally recognized and accepted cooperative purchasing agreement that has been developed utilizing a competitive bidding process by another contracting unit within the State of New Jersey, or within any other State, when available; and

**WHEREAS**, Houston-Galveston Area Council (H-GAC) is a nationally recognized and accepted cooperative purchasing contracting unit within the State of New Jersey that utilizes a competitive bid or competitive proposal process awarding contracts for goods and services and is authorized by New Jersey law to extend its contracts to local government units nationwide; and

**WHEREAS**, the Township of West Deptford (hereinafter referred to as "Township") authorized membership in the H-GAC Cooperative Purchasing Program pursuant to Resolution 2013-137 adopted on October 29, 2013; and

**WHEREAS**, the Township proposes to purchase one (1) New Rausch Eco Star 400 CCTV Inspection System in a Car-Mate Axle Trailer 6' x 14', effective February 29, 2020 through the completion and delivery of the New Rausch Eco Star 400 CCTV Inspection System in a Car-Mate Axle Trailer 6' x 14'.


