**RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING EXECUTION OF SHARED SERVICES AGREEMENT BY AND BETWEEN THE TOWNSHIP OF DEPTFORD AND THE TOWNSHIP OF WEST DEPTFORD FOR A CERTIFIED RECYCLING PROFESSIONAL TO PREPARE ANNUAL RECYCLING TONNAGE REPORT**

**WHEREAS**, beginning in 2012, each New Jersey municipality is required by the Recycling Enhancement Act (REA) to have mandatory Annual Recycling Tonnage Reports approved and "signed" by a Certified Recycling Professional (hereinafter "CRP"). Recycling Tonnage Reports will be submitted via email to the New Jersey Department of Environmental Protection (NJDEP) utilizing a spreadsheet compatible with the Microsoft Excel structure provided by the department; and

**WHEREAS**, West Deptford is a Municipal Corporation of the State of New Jersey, with its principal offices located at 400 Crown Point Road, West Deptford, New Jersey; and

**WHEREAS**, Deptford is a Municipal Corporation of the State of New Jersey, with its principal offices located at 1011 Cooper Street, Deptford, New Jersey; and

**WHEREAS**, West Deptford, by ordinance, has duly enacted a recycling plan for all recyclable materials as designated by the Gloucester County Solid Waste Management Plan and amendments thereto; and

**WHEREAS**, West Deptford has the need for a CRP to complete and submit its Recycling Tonnage Report; and

**WHEREAS**, Deptford has the capabilities to provide the services of its CRP to West Deptford; and

**WHEREAS**, N.J.S.A. 40A:65-1 et seq. ("Shared Services Law") specifically authorizes local government units, including counties and municipalities, to enter into shared services agreements; and

**WHEREAS**, the parties to this Shared Services Agreement agree that their mutual public purposes and their best interests will be promoted by the execution and delivery of this Agreement pursuant to the powers conferred by the Shared Services Law; and

**WHEREAS**, the Agreement shall be effective commencing upon the execution date of the Agreement and until December 31, 2020.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Township Committee of the Township of West Deptford, County of Gloucester, State of New Jersey, on this 18<sup>th</sup> day of March, 2020, that the Mayor and/or Acting Township Administrator are herein authorized to execute the attached Agreement by and between the Township of Deptford and the Township of West Deptford for the use of a CRP to complete and submit the West Deptford Recycling Tonnage Report.
