RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AMENDING RESOLUTION 2020-106 AUTHORIZING THE PURCHASE OF RAUSCH ECO STAR 400 CCTV BY THE TOWNSHIP OF WEST DEPTFORD AS PART OF THE HOUSTON-GALVESTON AREA COUNCIL COOPERATIVE PURCHASING PROGRAM

WHEREAS, the Township of West Deptford adopted Resolution 2020-106 on February 29, 2020 authorizing the purchase of a Rausch Eco Star 400 CCTV by the Township of West Deptford as part of the Houston-Galveston Area Council Cooperative Purchasing Program in the amount of \$160,000.00; and

WHEREAS, the original cost of \$160,000.00 was based on an invoice submitted by Pierce-Eagle Equipment Co. that did not include the desired dual axle trailer size; and

WHEREAS, the price for a Rausch Eco Star 400 CCTV with the desired 7 x 14' trailer is \$164,000.00 per the attached invoice provided by Pierce-Eagle Equipment Co.; and

WHEREAS, the Township has identified the needed change for the purpose of correcting the purchase price.

NOW, THEREFORE BE IT RESOLVED by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey as follows:

Section 1: That Resolution 2020-106 Authorizing the Purchase of a Rausch Eco Star 400 CCTV by the Township of West Deptford as part of the Houston-Galveston Area Council Cooperative Purchasing Program is hereby amended to reflect a change in the purchase amount of \$4,000.00 for a revised total purchase amount of \$164,000.00.

Section 2: That the Mayor and/or Acting Township Administrator are hereby authorized to execute any and all documents related to the purchase of a Rausch Eco Star 400

CCTV by the Township of West Deptford as part of the Houston-Galveston Area Council Cooperative Purchasing Program.
