**RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING THE EXECUTION
OF A PROFESSIONAL SERVICE CONTRACT PURSUANT TO A FAIR AND OPEN
PROCESS TO PROVIDE LICENSED SITE REMEDIATION PROFESSIONAL SERVICES FOR
THE YEAR 2019**

WHEREAS, West Deptford Township has determined that it shall use a fair and open process to acquire certain services in accordance with the provisions of N.J.S.A. 19:44A-20.5; and

WHEREAS, N.J.S.A. 19:44A-20.5 provides that contracts awarded through a fair and open process may be awarded based on price and other factors; and

WHEREAS West Deptford Township has determined there exists a need to acquire the services of a **Licensed Site Remediation Professional** as a fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.5; and

WHEREAS, this one (1) year contract shall commence on January 1, 2019 and terminate on December 31, 2019; and

WHEREAS, on November 30, 2018, the Township received responses to its request for proposals to provide Licensed Site Remediation Professional services for the Township of West Deptford; and

WHEREAS, funding for this contract shall be encumbered by the West Deptford Township Finance Officers in accordance with N.J.A.C. 5:30-5.4.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of West Deptford, Gloucester County, New Jersey, as follows:

1. That T&M Associates be and is hereby appointed Licensed Site Remediation Professional for the Township of West Deptford for the year commencing January 1, 2019, and ending December 31, 2019.
2. That the Mayor and Municipal Clerk are hereby authorized and directed to execute a contract with T&M Associates as Licensed Site Remediation Professional in accordance with the fee schedule submitted with the proposal with an hourly rate not to exceed \$91.- \$197. for services as defined in the contract. Said contract is awarded in compliance with rules and restrictions of N.J.S.A. 19:44A-20.5 and Chapter 53 of the Code of the Township of West Deptford.
3. A Notice stating the nature, duration, service and the amount of the contract and that this Resolution and contract are on file and available for public inspection in the office of the Township Clerk shall be published in *The South Jersey Times and/or Courier Post*.
