RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD APPOINTING MUNICIPAL COURT JUDGE FOR THE WEST DEPTFORD/NATIONAL PARK JOINT MUNICIPAL COURT

WHEREAS, West Deptford Township has determined that it shall use a fair and open process to acquire certain services in accordance with the provisions of N.J.S.A. 19:44A-20.5; and

WHEREAS, West Deptford Township has determined there exists a need to appoint a **Municipal Court Judge** for the West Deptford/National Park Joint Municipal Court as a fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.5; and

WHEREAS, the term of this appointment shall be for three (3) years and shall commence on January 1, 2019 and terminate on December 31, 2021; and

WHEREAS, on December 14, 2018, the Township received responses to its request for qualifications for Municipal Court Judge for the West Deptford/National Park Joint Municipal Court; and

WHEREAS, funding for this appointment shall be in accordance with the Township of West Deptford annual Salary Ordinance.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of West Deptford, County of Gloucester, and State of New Jersey as follows:

1. That Guy Killen, Esquire be and is hereby appointed Municipal Court Judge for the West Deptford/National Park Joint Municipal Court for a three (3) year term of January 1, 2019 to December 31, 2021.
2. That this appointment is made in compliance with rules and restrictions of N.J.S.A 19:44A-20-5 and Chapter 53 of the Code of the Township of West Deptford.
3. That the Municipal Court Judge shall be paid in accordance with the Township's Salary Ordinance.
4. A Notice stating the nature, duration, service and the salary and that this Resolution are on file and available for public inspection in the office of the Township Clerk and shall be published in *The South Jersey Times and/or Courier Post*.
