**RESOLUTION 2019-56**

**RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD ADOPTING A TEMPORARY BUDGET FOR THE TOWNSHIP OF WEST DEPTFORD FOR THE YEAR 2019**

**WHEREAS**, N.J.S. 40A:4-19 provides that where any contract, commitment or payments are to be made prior to the final adoption of the 2019 Budget, temporary appropriations should be made for the purpose and amounts required in the manner and time therein provided; and

**WHEREAS**, the date of the resolution is within the first 30 days of January 2019; and

**WHEREAS**, the total appropriations in the 2018 Budget, exclusive of any appropriations made for interest and debt redemption charges and capital improvement fund is the sum of \$33,451,518.72; and

**WHEREAS**, 26.25% of the total appropriations in the 2018 Budget exclusive of any appropriations made for debt service or capital improvement fund in the said 2018 Budget is the sum of \$8,781,023.66 and

**WHEREAS**, the New Jersey Statutes 40A:4-19 provides that temporary appropriations should be made for the amount of such debt service in the manner and time therein provided.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of West Deptford that the following temporary appropriations be made, and that a certified copy of this resolution be transmitted to the Chief Financial Officer for his records (as per schedule below):
