RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING THE SUPPLY AND DELIVERY OF ONE (1) A4 STORM STREET SWEEPER ON 2018 ISUZU CHASSIS OR APPROVED EQUAL (H.A. DEHART & SONS, INC.)

WHEREAS, the Township of West Deptford (hereinafter referred to as "Township") has a need to purchase one (1) A4 Storm Street Sweeper on 2018 Isuzu Chassis or Approved Equal for service in the Township; and

WHEREAS, the Township solicited for and received one bid for one (1) A4 Storm Street Sweeper on 2018 Isuzu Chassis or Approved Equal; and

WHEREAS, one sealed bid was received from H.A. DeHart & Sons, Inc. and opened on December 14, 2018 at 11:00 am; and

WHEREAS, H.A. DeHart & Sons, Inc. (hereinafter referred to as "DeHart") was determined to have submitted the lowest responsible bid for the purchase and delivery of one 2018 Schwarze NR254 on Isuzu Chassis in the amount not to exceed \$179,887; and

WHEREAS, as part of the bid proposal, DeHart has offered extended warranties as follows:

- A. Chassis – Isuzu
 - i. Extended Warranty - \$950.00
 - ii. Extended Warranty Plus - \$1,250.00
 - iii. After Treatment Warranty - \$1,500.00

- B. Sweeper – Schwarze
 - i. Silver 2 year or 2400 Hours - \$1,425.00
 - ii. Gold 3 Year or 3600 Hours - \$3,255.00
 - iii. Platinum 4 Year or 4800 Hours - \$4,500.00
 - iv. Diamond 5 Year or 6000 Hours - \$5,500.00

; and

WHEREAS, the Township has chosen to purchase the following extended warranties in addition to the cost of the street sweeper: After Treatment Warranty (\$1,500.00) and Diamond 5 Year or 6000 Hours (\$5,500.00) for the additional cost of \$7,000; and

WHEREAS, the Township desires to purchase one 2018 Schwarze NR254 on Isuzu Chassis with the extended warranties of After Treatment Warranty (\$1,500.00) and Diamond 5 Year or 6000 Hours (\$5,500.00) from DeHart in the total amount not to exceed \$186,887; and


WHEREAS, a Certification has been issued by the Chief Financial Officer of the Township of West Deptford certifying that sufficient funds have been appropriated and are available to cover this contract and the original of said Certification is attached to the original of this Resolution and shall be kept on file at the Township office.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of West Deptford, County of Gloucester, and State of New Jersey that the Township Committee hereby approves and authorizes the purchase and delivery of one 2018 Schwarze NR254 on Isuzu Chassis with the extended warranties from H.A. DeHart & Sons, Inc. in the total amount not to exceed \$186,887.

BE IT FURTHER RESOLVED that the Mayor and/or Township Administrator are hereby authorized to execute any and all documents related to this matter.
