RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AWARDING A CONTRACT FOR THE RIVERWINDS HOCKEY COURTS RESURFACING (NICKOLAUS CONSTRUCTION COMPANY)

WHEREAS, the Township of West Deptford (hereinafter referred to as "Township") has a need to award a contract for the RiverWinds Hockey Court Resurfacing; and

WHEREAS, the Township advertised for public bids for the RiverWinds Hockey Court Resurfacing; and

WHEREAS, sealed bids for the RiverWinds Hockey Courts Resurfacing were received and opened on January 31, 2019 as follows:

WHEREAS, Nickolaus Construction Company has submitted the lowest complete and responsive bid proposal for the RiverWinds Hockey Court Resurfacing in the amount not to exceed \$58,900.00; and

WHEREAS, T&M Associates has provided the attached Letter of Recommendation for Contract Award to the Township dated February 1, 2019 recommending that the Township award the contract for the RiverWinds Hockey Court Resurfacing to Nickolaus Construction Company in the amount not to exceed \$58,900.00; and

WHEREAS, a Certification has been issued by the Chief Financial Officer of the Township of West Deptford certifying that sufficient funds have been appropriated and are available to cover this contract and the original of said Certification is attached to the original of this Resolution and shall be kept on file at the Township office.


NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township


